COURSE PREREQUISITES/PREPARATION:

Students of this course should meet the following prerequisites before attending the class:

- Understanding of property and loss industry and terminology
- Basic computer skills:
 - Starting up and shutting down the computer
 - Using the keyboard and mouse; understanding of the left and right mouse buttons
 - Basic typing skills
 - Opening software applications
- External computer mouse
- Laptop with stand-alone version of Xactimate® 28

It is very important that you have an external mouse and stand-alone copy of Xactimate®, otherwise you will not be able to go forward in the class. Network copies will not work for class.

Laptop/software requirements:

- You will need a laptop with a working local copy of Xactimate® 28. The demo Xactimate® 28 will work as well
- You should have the program downloaded and working on your computer **5 days prior** to the class. This is crucial as you may need some technical assistance from Xactimate® to install the program onto your computer depending on your security settings of your laptop and server.

- You will need to set up a user profile and the download is approximately 1 GB, therefore **prepare to download for approximately 1 to 2 hours**.
- When you fill out the detailed information for downloading the program, they will send you a user key code that you will enter to access the demo.
